A362 Works The notes from Simon's meeting with officers of WC and the contractor and the Road Closure notice had previously been circulated. It was noted that the drainage work had started and Simon reiterated that whilst the work would improve the current situation there was no guarantee that it would resolve the issue completely.

Gill clarified the position of the 'layby' at the junction of Deep Lane with the A362. It is not a layby it is a bus stop. Simon will establish the status of this area and pursue its proper marking with the Council. A question was asked regarding tree lopping along the stretch. Simon advised that it was not within the scope of what is proposed. He has informally asked the question (some months ago) and had the response that the official limit is 5.1m and that Wiltshire rely on the passage of vehicles to enforce that limit which is pretty impractical to even check unless it is grossly out of limits.

A question was asked about the water across the road at Lane End and the potential danger if this froze later in the year. Simon agreed to take this up with our Community liaison officer.

# 13/94 Public Footpath(s)

Gill reported that the footpaths in the parish were not in good condition.

With reference to the particular query that had been raised she had discussed it with the parisioner who had raised it.

Gill also advised that the section responsible for footpaths at Wiltshire Council have a huge work load with the resultant deleterious effect on maintenance work on footpaths throughout the county. She suggested that it would be possible to establish a 'Footpath support group' within the parish, along the lines of the Litter pickers, that could effect some improvement locally. There are monies available for the establishing and equipping of such groups. After discussion, during which concern was expressed at the possible effects if such a group took on some of the existing WC responsibilities but then at some point in the future was unable to fulfil them, would the council then refuse to 'take it back', it was agreed that Gill should investigate the establishing of such a group and come back to the PC with some suggestions as to how it might work, funding options and how to mitigate the concerns expressed.

# 13/95 Training

Councillors were recommended to read the newsletters from WALC that were circulated to appraise themselves of what training opportunities were available.

The Chair reported that he had met with the Chair of Chapmanslade to discuss the concerns that had been expressed and the Editor of the Bridge agreed to alter the home page title to read simply "The Bridge" and remove "Corsley" This could alleviate the reported major concerns of Chapmanslade.

The PC was uncertain that this was something they should be involved in and agreed they would take no action pending any expression of interest within the Parish.

Care of Trees Planted on the Old School Playing Field

Judith reported that weeds appeared to be smothering the trees planted on the Old School Playing Field and asked what plans were in place to ensure that the investment made in the planting should not be wasted. It was agreed that this form part of the budget setting discussions in December.

**Care of the Millenium Stones** It was reported that the lettering on the Millenium stones about the parish was becoming unreadable. It was agreed that this also should be considered as part of the budgetary discussions.
